BECAUSE WE DON'T WANT TO LIVE THROUGH ANOTHER DEVASTATING FLOOD LIKE THE 1941 DISASTER, NOR SUFFER THE SAME CONSEQUENCES AS OTHER BARRANCO REDUCTIONS IN TENERIFE AND MADEIRA: **DEATH AND MILLIONS OF EUROS DAMAGES**

BECAUSE **WE DON'T HAVE RESERVOIRS** TO HELP CONTROL THE WATER FLOW

BECAUSE CEMENTING THE RIVER BED WILL **REDUCE BOTH BEACH SAND AND WELL WATER**

BECAUSE THERE IS NO CERTAINTY THE MONEY SPENT WILL BENEFIT THE TOWN: THE PROJECT DOES NOT NECESSARILY REQUIRE LOCAL LABOUR. THE 8 MILLION EUROS WILL BE POCKETED BY BIG COMPANIES


BECAUSE VALLE GRAN REY'S ECONOMY IS BASED ON TOURISM, WHICH WILL NOT WITHSTAND 2 YEARS OF DISRUPTIVE WORKS INVOLVING REMOVAL OF OVER **150.000 TONS OF EARTH, OVER 1.000 TRUCKLOADS OF RUBBLE AND CEMENT AND 60.000 HOURS OF NOISE AND NUISANCE** FOR EVERYONE
